

**Call to Burleigh County Clerk of Court's Office by Alex "Distance" Wilson

**Call Length: 3:01**

**Summary:** Distance calls the Burleigh County Clerk of Court at the number she was given to call at the Morton County Clerk of Court's Office, & is informed that she needs to call the Morton County Clerk of Court's Office to find out "where her Notice to Appear for her 4-20-2017 was sent".

**TRANSCRIPT:**

**Automated Voice:** You have reached the South Central District Court. If you know your party's 3-digit extension, you may dial it at any time. To reach the Burleigh County Clerk Office, please press "3".

*Distance presses "3".*

**Another Automated Voice:** You have reached the Burleigh County Clerk of Court's Office. Please listen closely to this entire greeting as our options have changed. Our office hours are 8-5 Monday through Friday. If you are calling regarding a citation issued by the city police, call the Bismarck Municipal Court at 355-1350. If you are calling for *Civil, Divorce, Child Support, or Small Claims*, press "1". For *Fines, Fees, or Criminal Case information* on a hearing date, press "2".

*Distance presses "2".*

**Distance:** I pressed "2".

**Burleigh County Clerk of Court:** Clerk of Court.

**Distance:** Hello. I was informed through the State's Attorney's Office that I am scheduled for a case tomorrow

**Burleigh County Clerk of Court:** Okay.

**Distance:** A court appearance, & I talked with somebody else who also has a court appearance tomorrow, & neither they nor I appear to have been informed from your office that we have court today – or *tomorrow morning (rather)*.

**Burleigh County Clerk of Court:** Well we don't just put on hearings without informing you of them. What's your name?

**Distance:** Alex Wilson.

**Burleigh County Clerk of Court:** Wilson is the last name?

**Distance:** Uh huh.

**Burleigh County Clerk of Court:** And how do you spell your first name?

**Distance:** A-L-E-X.

**Burleigh County Clerk of Court:** And its W-I-L-S-O-N?

**Distance:** W-I-L-S-O-N. Yep.

**Burleigh County Clerk of Court:** You don't have a hearing in my court.

**Distance:** Okay I was just transferred to here. Its in the Morton County Clerk of Court.

**Burleigh County Clerk of Court:** Okay *you need to contact* Morton County Clerk of Court.

**Distance:** Okay *this is the number they gave me for my case.* Okay.

**Burleigh County Clerk of Court:** Well it is 701-667-3358.

*Distance repeats the number.*

**Distance:** Thank you.

**Burleigh County Clerk of Court:** Sure.

**Distance:** Bye.

**Burleigh County Clerk of Court:** Bye.
