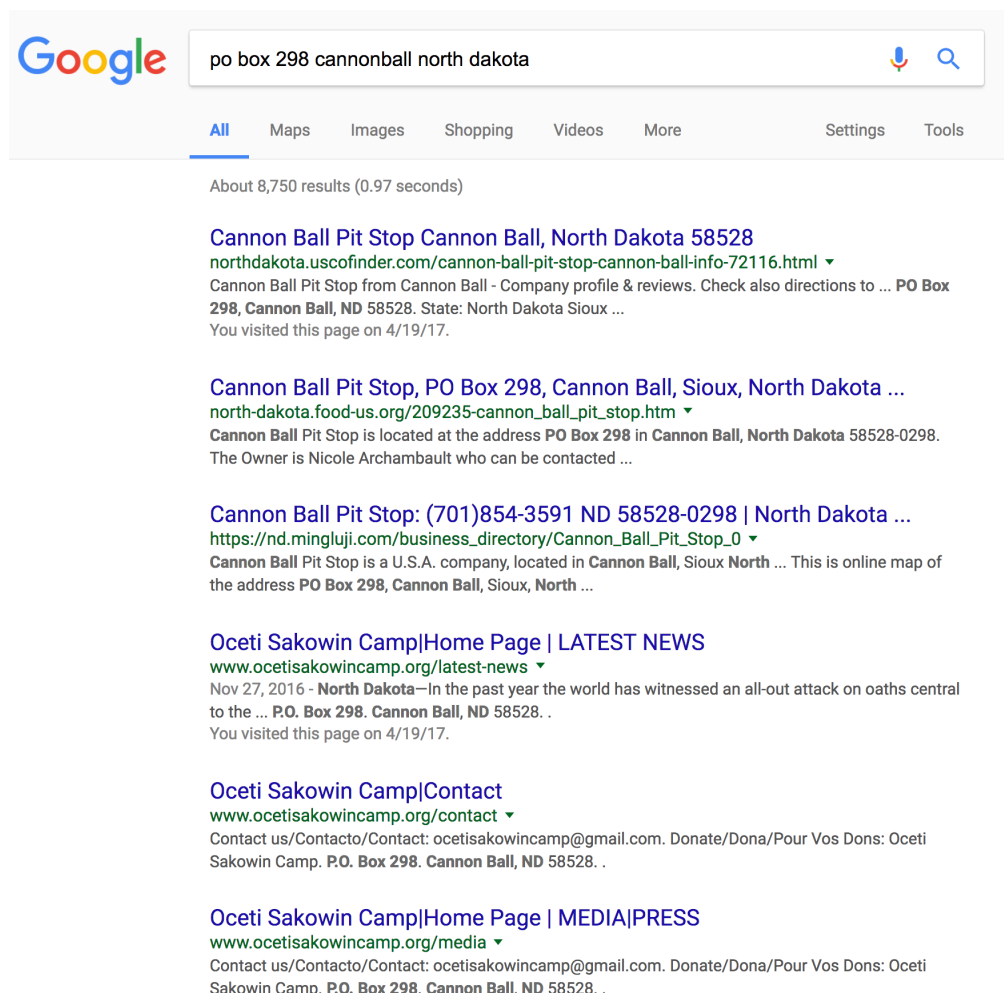


Your Honour, & All Whom This May Concern:

Yesterday (4-19-2017) I called the ND State Attorney's Office for the second time because my call the first time about a week ago had not been returned yet. The purpose of both calls was in response to the 'STATE'S DISCOVERY RESPONSE and REQUEST and NOTICE OF INTENT (N.D.R.Evid. 707)' that was sent to me at 141 Lansdale in Fairfax, California on 3-21-2017 (see attached). During the phone call I was informed for the first time of my court appearance scheduled for today. This gave me a feeling of anxiety in that I was unprepared due to the fact that I had not received any notices in the mail with regards to such! I informed the woman on the phone that I had not received a notice, & she transferred my call to Burleigh County Administrative Office, from where the notice was said to have been mailed to me on 1-20-2016.














After my call was transferred transferred, this next woman confirmed that indeed the notice had been sent on 1-20-2016. I inquired as to which address they had on file, & the woman told me they had "P.O. Box 298 Cannonball, North Dakota 58528". I was surprised & confused by this, because this is not an address I would have chosen to give to have notifications sent, & so I informed the woman on the phone & requested to change the address to where I *do* receive mail, to which she confirmed she had amended within the database so that I will receive future mailings.

After hanging up, I searched Google to discover who is registered to P.O. Box 298 in Cannonball. Here is a screenshot of what I saw:
