

#### Case Narrative

249 - Jones, Jacob G, Created: 10/15/2016, Last Modified: 10/15/2016

This report concerns my assistance to Morton County Sheriff's Department on 10/15/2016 at approximately 09:15 hours. It also concerns the arrest of Alexandra Wilson (also known as Alexander Wilson) on the same date for disorderly conduct.

- -1, Trooper Jones, was dispatched to protest activity south of Mandan, ND on Highway 6. When I arrived at Application of Highway 6 and Morton CR 135 I observed a large group of protesters standing on the road and blocking Highway 6. I was assigned to an arrest team. I heard law enforcement commanders instruct the protesters that it was an unlawful protest and they were ordered to disperse immediately or they were subject to arrest. Several arrests were made by other law enforcement of protesters refusing to leave.
- -Suspect- Alexandra Wilson was being loud and verbal and refused to leave. Lt. Stuglemeyer went out in front of the crown control line and identified Alexandra as needing to be arrested. She was escorted back through the line and I told her she was under arrest. I zip cuffed her behind her person and then escorted her over the transport van holding area. I did a quick search of her person and purse for weapons and any identification. I found no weapons but found a California driver's license that identified her as Alexandra Distance Marie Wilson. Upon running the drivers license this individual is also known as Alexander James Wilson.
- -I filled out an affidavit and gave it to the transport people, turning custody over to them.
- -This ended my involvement.

#### 310 - Mehlhoff, Brian L, Created: 10/15/2016, Last Modified: 10/15/2016

I was contacted by a CODE RED at 7:48 on October 15, 2016 concerning a convoy of protesters leaving the protests camp south of Fort Rice. I responded to the intersection of County Road 135 and Hwy 6 just before a convoy of approximately 15 cars arrived traveling north. Myself and other units blocked the Highway to prevent them from getting to the Construction site on Highway 6 approximately 2 miles to the north of us. DAPL pipeline workers were actively working and we blocked the protesters from reaching them for their safety. Protesters stopped before our vehicles and exited their cars. We set up a perimeter and told them they had to stay behind the cones.

Lt. Stuglemeyer of the Bismarck PD. gave verbal commands to the crowd of about 50 to disperse or they would be arrested. The crowd was blocking the roadway and failed to disperse. 2 rounds of arrests were made by other officers. I placed a protester, later identified as James Troy, under arrest for Disorderly Conduct after 3 warnings to disperse. I witnessed Troy not following commands to disperse and standing on the roadway which in turn obstructed vehicular traffic. I placed him under arrest by placing him in zip cuffs behind the back. I searched his person and released custody to Parole and Probation who was in charge of the transport van. I returned to the unlawful protest.

On 10/15/2016 at approximately 0900 hrs I arrived at a standoff with DAPL protesters on HWY 6 on the south side of the junction with Co Rd 135.

A large group of protesters were on the highway, completely blocking the roadway. One of the law enforcement officers on scene gave commands over a bullhorn for the crowd to disperse several times. The crowd was tumultuous and refused to comply with the orders to disperse. Protesters began sitting on the shoulder of the road and linking arms to form a human chain. Deputy Middleton and I approached one of the protesters, later identified as Ty Bray, and told him he was under arrest. We then pulled him out of the line and handcuffed him with plastic zip cuffs. He was searched and sat in the north ditch awaiting transport.

While we waited for the transport van Bray identified himself by name and date of birth. When the van arrived I completed and affidavit for disorderly conduct, informed Bray of the charge, and turned him over to the transport team.

I was later informed by ASA Goter that the charge would be amended to Engaging in a Riot.

On 10/15/2016 at approximately 0900 hrs I arrived at a standoff with DAPL protesters on HWY 6 at the intersection of Co Rd 135.

There was a large crowd of protesters on Hwy 6, they were blocking the roadway. Several protestor vehicles were parked behind the crowd.

Commanding officers gave several orders to disperse on the bullhorn. The crowd was informed that if they did not immediately comply they would be arrested. The crowd reacted verbally after hearing these orders.

4-5 protestors began sitting on the east shoulder of Hwy 6 and linked arms. I, along with several other officers on the arrest team, approached these individuals. They were informed they were under arrest. I took Jeffrey T. Nichols-Haining DOB: 12-31-89 into custody at approximately 0910 hours. Jeffrey was handcuffed (plastic zip cuffs) behind the back. He was pat searched for weapons and walked to the NE ditch to gather information and to await transport. Jeffrey was informed that he was being charged with Disorderly Conduct.

Jeffrey willingly gave his information: Name, DOB, address, height, weight, hair & eye color and place of birth being Bakersfield CA. Jeffrey was cooperative while waiting for transport. He would ask for permission to sit or stand before doing so.

I completed an affidavit for disorderly conduct and turned Jeffrey over to transporting officers.

On 10/15/2016 at approximately 0900 hrs I arrived at a standoff with DAPL protesters on HWY 6 at the intersection of Co Rd 135.

There was a large crowd of protesters on Hwy 6, they were blocking the roadway, the protesters were yelling back that they were protecting the water. One of the lead law enforcement officers on scene was using a bullhorn telling the protestors to disburse or they would be arrested after several failed attempts at getting the protestors to leave.

I with 3 other law enforcement officers were on an arrest team. At about 09:10 hours male protestor in front of me was very load and out spoken. He was getting the rest of the protestors agitated. He told that he was under arrest for disorderly conduct we removed him from the group we used flex cuffs to secure his hands behind his back. I asked the male if he had any identification on him he said no. I asked him for his name and date of birth He identified himself as David Darrin Aker (DOB 7-19-1969). I asked Aker where he was from he said that he has been in ND for 30 days so Cannon Ball ND was his new home. When Arker was being searched, one of the other officers found a 2-way radio in his pocket. The radio was taken as evidence.

I completed an affidavit for disorderly conduct and turned Aker over to transporting officers.

I left Aker with other officers and went back to the arrest teams at about 09:30 hours. I and a couple other officers arrested a tall white male yelling and banging on a rawhide drum. He was told that he was under arrest. He was resisting arrest by not allowing us to put his hands behind his back so he could be handcuffed with flex cuffs. One of the officers took the drum and the male said be careful with that. He said that the drum was special and that he wanted the drum to be given to one of the other protestors. We said that we would give the drum to his friend if he would stop resisting. The male said fine and relaxed his arms. We got the flex cuffs on the subject and handed the drum off like we said we would. I took the male over to the transport van and I asked Him for his name and date of birth. The male said that he was not going to assist us with prosecuting him. One of the officers on the arrest team found a pill bottle on him, I looked at the bottle and asked the male if the medicine was his. He asked who else do you think it would be. Well I said that he could have been holding it for some one else. The male said the the medicine was his and it was for his PTSD and that he had quit taking it because since he came camp he didn't need it any more. The name on the pill bottle was Cody Saint I asked the male again what his name was. He was not really willing to talk I said I need to know your name so I know that the bottle was his. He said his name was Cody Saint but he would not give a date of birth.

I completed an affidavit for disorderly conduct and turned Saint over to transporting officers.
